**SUBJECT: REVISIONS TO THE FINAL NOTICE BEFORE DISCONNECTION FORM**

San Diego Gas & Electric Company (SDG&E) hereby submits for filing the following revisions applicable to its electric and gas tariffs, as reflected in Attachments A and B, respectively.

**PURPOSE**

This filing makes minor modifications to SDG&E's Final Notice Before Disconnection Form (Form No. 101-00752) including adding a sentence to notify customers that there are alternative payment options available and updating the list of company offices where bills may be paid.

**EFFECTIVE DATE**

SDG&E respectfully requests that this Advice Letter become effective on September 10, 2003, which is 40 calendar days after the date filed.

**PROTEST**

Anyone may protest this advice letter to the California Public Utilities Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and received within 20 days of the date this advice letter was filed with the Commission. There is no restriction on who may file a protest.
