PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

**SUBJECT: REVISIONS TO ELECTRIC TRANSMISSION RATES EFFECTIVE
SEPTEMBER 1, 2009**

San Diego Gas & Electric Company (SDG&E) hereby submits for approval the following revisions to its electric tariffs as shown in the enclosed Attachment B.

PURPOSE

This filing revises SDG&E's electric transmission rates effective September 1, 2009 through August 31, 2010, pursuant to its Transmission Formula Rate Mechanism for its TO3 Cycle 3 filing, which was filed with the Federal Energy Regulatory Commission (FERC) on August 17, 2009.

BACKGROUND

Pursuant to SDG&E's FERC-approved transmission formula and in accordance with the FERC-approved Settlement¹, on June 15, 2009 SDG&E posted a draft of the TO3 Cycle 3 Informational Filing on its website for review and comment by interested parties, including the California Public Utilities Commission (Commission).² On August 17, 2009 SDG&E filed with FERC in Docket No. ER09-1601-000 its annual Transmission Rate Filing (Cycle 3) to adjust its Base Transmission Revenue Requirements (BTRR) for end use customers and wholesale customers, effective September 1, 2009. This filing allows SDG&E to collect only the transmission related expenses it incurs at an allowed return on equity equal to 11.35%. SDG&E's annual BTRR will decrease by approximately \$26 million to \$271 million for the 12-month effective period ending August 31, 2010. Consistent with FERC approved Docket No. ER09-295-000, rates implemented with this Advice Letter reflect the shift from non-coincident to peak-related transmission demand charges for certain Medium and Large Commercial and Industrial schedules.³

² Initial posting of SDG&E's TO3 Cycle 3 Informational Filing occurred on June 15, 2009. A July 17, 2009 posting included further updates to Base Transmission Revenue Requirements.

³ For Schedules AY-TOU, AL-TOU, AL-TOU-DER, DG-R and A6-TOU this represents a 10% reduction in transmission non-coincident demand charge with the revenues associated with the non-coincident demand charge reduction recovered through new peak-related transmission demand charges.

Commission Resolution E-3930, approved on May 26, 2005, established a new process for review by the Commission of FERC-jurisdictional rate changes. Page 7 of the Resolution states the following:

“The Commission recognizes that under the filed rate doctrine, the Commission should allow a pass through of these transmission rates that are filed with and become effective at the FERC”.

Therefore, in compliance with the process outlined in Resolution E-3930, SDG&E is filing to revise its electric transmission rates effective September 1, 2009, subject to refund, concurrent with the date they become effective at the FERC.

Consequently, this Advice Letter implements the above-described changes in SDG&E’s electric rates commencing September 1, 2009. Consistent with D.04-02-057, total (commodity plus non-commodity) residential electric rates for usage up to 130% of baseline remain unchanged. SDG&E’s total system average electric rates will decrease by approximately 0.146 cents/kWh or 0.87%.

A table summarizing the rate impacts by customer class for both the transmission only rate adjustment (proposed in this Advice Letter) and the overall rate adjustment that will occur on September 1, 2009, is included herein as attachment A.

EFFECTIVE DATE

SDG&E believes that this filing is subject to Energy Division disposition and should be classified as Tier 1 (effective pending disposition) pursuant to GO 96-B. SDG&E respectfully requests that this filing become effective on September 1, 2009, subject to review by the Commission’s Energy Division.

PROTEST

Anyone may protest this Advice Letter to the California Public Utilities Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received within 20 days of the date this Advice Letter was filed with the Commission. There is no restriction on who may file a protest.
