**SUBJECT: PARTIAL SUPPLEMENTAL: REVISIONS TO ELECTRIC CTC AND EECC  
RATES IN COMPLIANCE WITH D.10-04-010 EFFECTIVE MAY 1, 2010.**

San Diego Gas & Electric Company (SDG&E) hereby submits for filing the following revisions to its electric tariffs as shown in the enclosed Attachment B.

**PURPOSE**

This partial supplemental Advice Letter (AL) is being filed to submit Sheet 2 of Schedule DR-TOU. This sheet was inadvertently omitted from SDG&E AL 2166-E filed on April 19, 2010. Pursuant to California Public Utilities Commission (Commission) Decision (D.) 10-04-010 approved on April 22, 2010, SDG&E is filing this advice letter to adopt its 1) 2010 Energy Resource Recovery Account (ERRA) revenue requirement, 2) 2010 Competition Transition Charge (CTC) revenue requirement, and 3) 2010 market benchmark price. As a result, this filing revises SDG&E's CTC, and Electric Energy Commodity Cost (EECC) rates effective May 1, 2010.

**BACKGROUND**

On October 1, 2009, SDG&E filed its 2010 ERRA revenue requirement forecast in Application (A.) 09-10-003. The ERRA balancing account records SDG&E's fuel and purchased power revenues against actual recorded costs, excluding revenues collected for the California Department of Water Resources (CDWR). SDG&E's 2010 CTC revenue requirement forecast was also included in this application which is calculated based on the market benchmark price authorized in D.10-04-010.

D.10-04-010, approves SDG&E's forecasted 2010 ERRA revenue requirement of \$827.96 million, a decrease from the 2009 ERRA revenue requirement of \$874.56 million, effective May 1, 2010. The 2010 ERRA forecast is less than 2009's forecast primarily due to lower costs for fuel and market purchases, combined with higher market sales and lower hedging costs. The decision also approves SDG&E's 2010 CTC revenue requirement forecast request of \$46.91 million, setting the 2010 market benchmark price for calculating CTC at \$58.54 per megawatt hour (MWh), and \$61.05 per MWh for calculating the Power Charge Indifference Adjustment (PCIA). Additionally, in compliance with Resolution E-4226 dated October 29, 2009, SDG&E is

authorized to revise Schedules DA-CRS (Direct Access Cost Responsibility Surcharge) and CCA-CRS (Community Choice Aggregation Cost Responsibility Surcharge), to calculate the PCIA to vary by customer class in the same proportion as the ongoing CTC, in their next scheduled CRS updates for 2010 rates<sup>1</sup>. CTC revenues are recorded to the Transition Cost Balancing Account (TCBA). The purpose of the TCBA is to record CTC revenues and CTC-eligible generation-related costs.

### Summary

This Advice Letter implements the above-described changes in SDG&E's electric commodity and CTC rates commencing May 1, 2010. The total net \$44.1 million decrease to the revenue requirement resulting from these changes is summarized as follows.

SDG&E's total system average electric rates will decrease by approximately 0.254 cents/kWh (1.58%). Included as Attachment A to this filing is a table summarizing the rate impacts by customer class.

### EFFECTIVE DATE

This filing is classified as a Tier 1 (effective pending disposition) pursuant to GO 96-B. SDG&E respectfully requests that this filing become effective on May 1, 2010, in accordance with D.10-04-010.

### PROTEST

Anyone may protest this Advice Letter to the California Public Utilities Commission. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. The protest must be made in writing and must be received no later than May 9, which is 20 days of the date this Advice Letter was filed with the Commission. Utility Distribution Company (UDC) Total Rate shown above excludes any applicable commodity charges associated with Schedule EECC and Schedule DWR-BC (Department of Water Resources Bond Charge).
